Good evening and welcome to Government House for this reception to acknowledge supporters of Impact 100 Tasmania.

I begin by paying my respects to the traditional and original owners of this land— the Mouheneener people. I acknowledge the contemporary Tasmanian Aboriginal community, who have survived invasion and dispossession, and continue to maintain their identity, culture and Indigenous rights.

Before commenting on the work of Impact 100, I'd like to make a pleasant observation that links Government House to this particular group — and it is that Alex's sister Shona Prior is one of our wonderful Honorary Aides-de-Camp.

I understand that your modus operandi is an annual membership subscription of \$1000, which goes directly to a charity, bypassing administrative and other costs. It's such a smart idea that one wonders why it's a relatively new global initiative.

So well done for making the decision to establish the group here in Tasmania. Last year, Family Planning Tasmania was voted as your inaugural Grant Winner. I look forward to seeing which Tasmanian charity will benefit so well financially this year.

And of course you are keen to grow your membership. Believe me, Dick and I will spread the word whenever we think that feasible, not least because we know the positive impact of – I use the word deliberately – charitable assistance on the lives of struggling Tasmanians.

I'll conclude by quoting this irresistible little statement on your website:

"We always knew that Impact 100 Donors were generous - turns out they're TRENDY, too! Collective giving has been identified as one of the biggest trends in philanthropy."

So, you bunch of trendy givers, do enjoy the reception and perhaps we'll see you again at a reception here next year.
